



## Rules & Eligibility

- 1. The "Global IT Scholarship Program" is open to any applicant who:**
  - Has a high school diploma or GED equivalency.
  - Must be at least 18 years of age
  - Must be interested in the Information Technology field and training at Global Information Technology
  - Must be able to attend classes in person, and must attend classes regularly. (Scholarships are currently not available for online students)
  - Student must be able to pay for training materials and examinations where necessary.
  - Must complete scholarship application and essay through the following link: [Scholarship Application Form and Essay](#)
  - Must have access to the internet and an existing email account.
  - Offer excludes all current employees, officers, directors and agents of Sponsors and its related companies and members of their immediate families (defined as spouse, parents, siblings and children) and persons residing at the same address are not eligible to win.
  - Void where prohibited.
- 2. HOW TO ENTER:** There is no purchase necessary to apply for the Scholarship. To enter, submit a completed Scholarship Application Form and Essay online at the Sponsor's Website no later than the 15th of a month, 11:59 pm Eastern Daylight Time. Limit one (1) Application per person. Valid ID will be required at time of award. Applicants with multiple entries will be automatically disqualified. Scholarship Application must be completed in full for the application to be eligible. Written response to open ended questions must be in English and must not exceed prescribed word limit. No substitutions will be accepted once you have submitted your original Application. All Applications become the property of the Sponsor and will not be returned. Sponsor assumes no responsibility for lost, late, misdirected, or unintelligible entries. Each Applicant hereby acknowledges that such Applicant does not reserve any rights in and to the written response submissions.
9. **DISPUTE RESOLUTION:** Except where prohibited, by participating, Applicant agrees that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participants and Sponsor and their agents shall be governed by and construed exclusively in accordance with the laws of the State of New York without giving effect to any principles of conflicts



of law of any jurisdiction. Applicant agrees that any action at law or in equity arising out of or relating to this Scholarship Program, or awarding of the award, shall be filed only in the state or federal courts located in the County of New York, State of New York and Applicant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such action. Except where prohibited, by participating in this Scholarship Program, Applicant agrees that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Scholarship Program, or awarding of the Scholarship Prizes, shall be resolved individually, without resort to any form of class action; and (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with participating in this Scholarship Program but in no event attorneys' fees; and (c) under no circumstances will any participant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. Each Applicant hereby agrees to indemnify and hold the Sponsor harmless from and against any and all third-party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of Applicant hereunder.
11. **FURTHER DOCUMENTATION:** Except where prohibited, potential Scholarship Recipient will be required to complete and return a Publicity/Liability Release within seven (7) days of notification or the sponsorship will be deemed to have been withdrawn. If notification to a potential Scholarship Recipient is returned as undeliverable, the sponsorship will be deemed to have been withdrawn.
